


2013 General Fund Expenditures




2013 General Fund Revenue



General Fund Revenue & Expenditures





Investment Income




SEEFRIED PROPERTIES

Wood County received \$1,446,968.94 in 2013.


ODOT Bridge Projects




Wood County Justice Center




In November, two tornadoes touched down on the same day causing damage from North Baltimore to Jerry City with extensive damage in Perrysburg and Lake Township as well.

County Completes Upgrade to Countywide Fire Channels

- Emergency Management Agency worked with the Sheriff's Office to upgrade the current radio canopy system for Wood County
- Enhancements provide better coverage and more options for fire and EMS services
- Homeland Security Grants provided some funding with a small portion from County General Fund

Applications must be received by June 2, 2014, to apply as a 2013 Late Applicant.

New Applicants income limitation of \$30,500 for 2014 must be met to qualify




